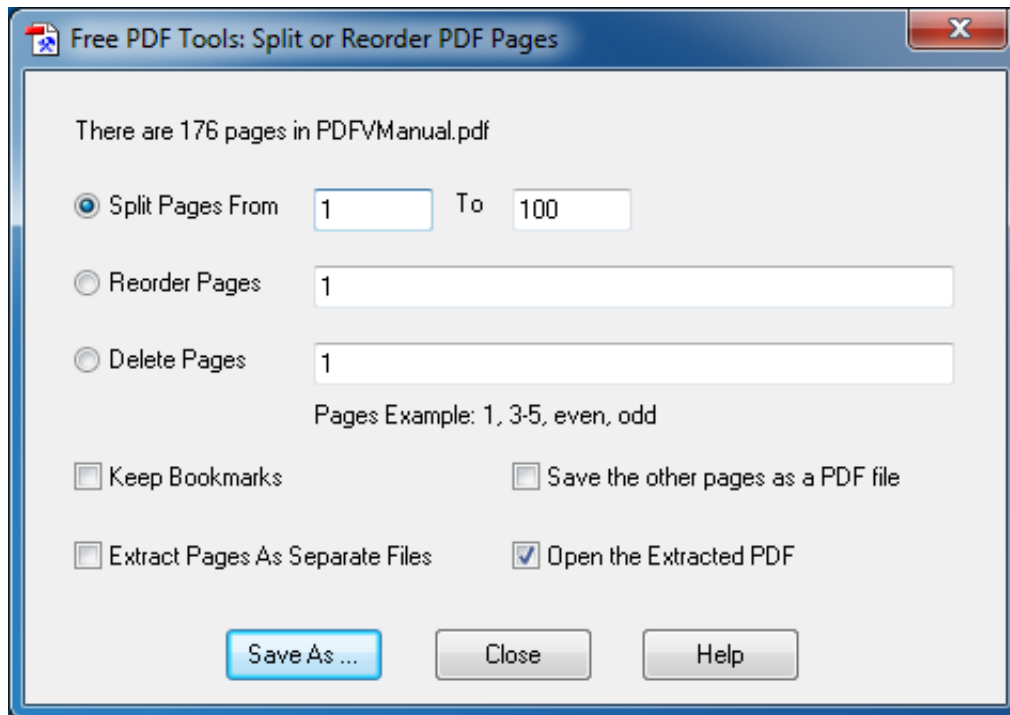

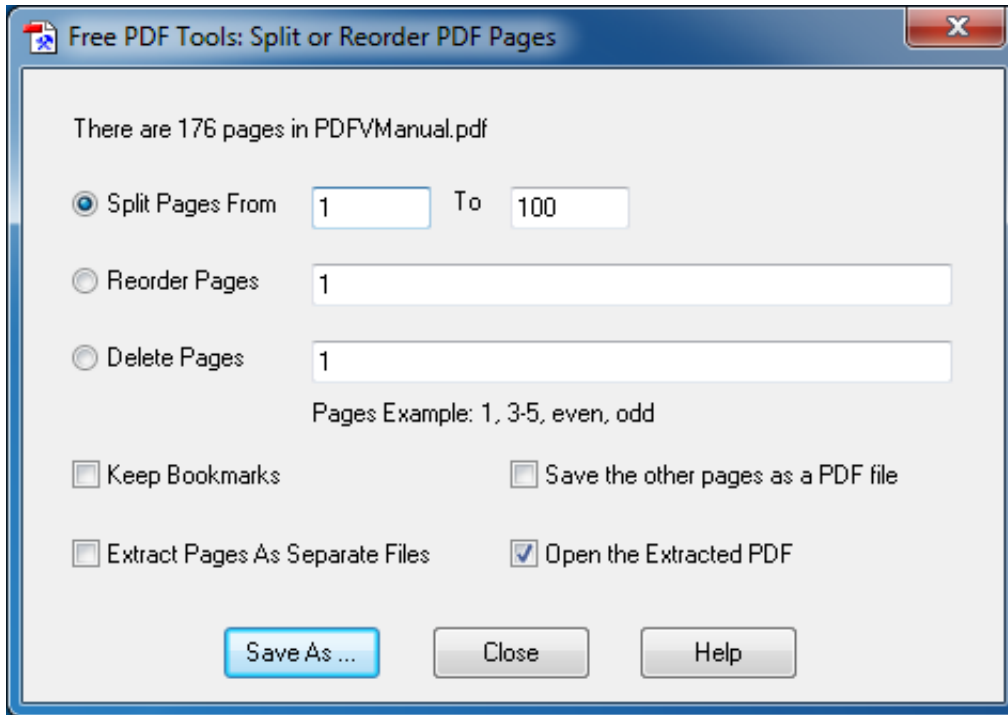

Once initiated, the payments must be maintained for the greater of either 5 years and a day, or until one reaches the age of 59 1/2, the age at which IRA withdrawals can usually avoid the early withdrawal penalty tax.. In addition, once an SEPP program has been established for an IRA, a lump sum withdrawal from the IRA before the tenure requirements have been met (age 59 and 1/2 or five years and a day) will trigger the penalty tax..
